POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 19 MAY 2025

All the resolutions as set out in the AGM Notice were duly passed by the shareholders of the Company by way of poll at the AGM.

At the Annual General Meeting of Glorious Sun Enterprises Limited (the “Company”) held on 19 May 2025 (the “AGM”), a poll was demanded by the Chairman for voting on all the resolutions as set out in the notice of the AGM dated 22 April 2025.

As more than 50% of the votes were cast in favour of each of the above resolutions numbered 1 to 5, all the above resolutions were duly passed as ordinary resolutions of the Company.

The full text of the above resolutions was set out in the notice of the AGM dated 22 April 2025.

As at the date of the AGM, the total number of issued and fully paid up shares of the Company was 1,501,212,000* shares, which was the total number of shares entitling the holders to attend and vote for or against all resolutions at the AGM. There were no restrictions on any shareholders casting votes on any of the resolutions at the AGM.

All directors of the Company attended the AGM in person.

* For the avoidance of doubt, there are in existence 1,520,000 shares of the Company which have been repurchased pending cancellation and the 1,501,212,000 shares mentioned herein do not include such repurchased shares.
