The Group's 9 Subsidiaries Recognised as “Good MPF Employer 5 Years+” and Received “MPF Support Award”

Organized by Mandatory Provident Fund Schemes Authority (MPFA), The Good MPF Employer Award 2020-2021 Presentation Ceremony cum Post-pandemic Business Intelligence Sharing Session was held on 5 October 2021. The Secretary for Labour and Welfare Dr Law Chi-kwong, GBS, JP and the Commissioner for Labour Mr Chris Sun Yuk-han, JP were invited as officiating guests of the event.

Glorious Sun Group regularly disseminates Mandatory Provident Fund (MPF)-related information and provides supporting services to employees over the years. This year, all Glorious Sun Group subsidiaries have been honoured as “Good MPF Employer” and received “MPF Support Award” in recognition. The MPFA has organized the Good MPF Employer Award for seven consecutive years, in total 1,740 companies/organizations have been honoured as “Good MPF Employers”. It is the highest number since the launch of the award and reflects that employers are attaching greater importance to providing better retirement protection for their employees.
